No charges for ACH accounts. \$275 <u>one-time family referral discount</u> after new family's 2 months of continued care. \$160 <u>sibling discount</u> applied toward monthly tuition statement for the older sibling. \$160 <u>vacation discount</u> applied toward the monthly tuition two times per calendar year.

Payment and Tuition Policies

School-Year Tuition Schedule

- The 2026–2027 tuition fee schedule applies to the full school year from Sept. 1, 2026, to Aug. 31, 2027.
- Monthly tuition is due on the 7th of each month unless otherwise noted (i.e., tuition express processing date)

Closures and Absences

- No tuition adjustments, credits, or refunds issued when the program is closed due to inclement weather, scheduled winter or summer breaks, federal holidays, illnesses, a child's birthday, class changes, family vacations.

Withdrawal Notice and Deposit Credit

- Either Little Stages or the family must provide 30 days' written notice for withdrawal from the program.
- Upon receipt of a withdrawal notice, the month's deposit will be credited toward the final month of care.
- 2 weeks of vacation discount requires 30 days' notice & only applies to enrolled families with continued care for six months.

Refunds and Withdrawal

- Refunds are not issued if a family relinquishes enrollment or withdraw from Little Stages.
- Little Stages is a non-contracted program.
- Families may discontinue service at any time with 30 days' written notice.

Enrollment Packet and Initial Payments

- To secure enrollment, families must submit all completed enrollment forms, a one-month deposit, the first month's tuition, and the one-time non-refundable registration fee.
- Enrollment is confirmed once Little Stages receives the completed enrollment packet with a start date.

Delayed Start of Care

- Space cannot be held or guaranteed after four weeks of non-attendance beyond the scheduled start-of-care.
- Please communicate any schedule changes in advance if they may delay your child's start of care due to parental leave.
- Tuition payments may be required if enrollment is delayed beyond 30 days after the scheduled start date and until care begins.
